Metro Stickers: Hassle for Students

At 9:30 a.m. on the fourth of March, 1977, better than two dozen Trevecca students appeared in the Metropolitan Nashville Court. All pleaded guilty as charged. Never before in the history of the college have students been involved in such a widespread violation of the law. Furthermore, there are other lawbreakers who have yet to be caught. The search continues.

Before fear and chaos break loose and students all start looking suspiciously at each other, it should be noted that these crimes have not been criminal offenses. The Court mentioned is traffic

court and the offense is violation of the Metro Registration sticker law. Of late the enforcement of this ordinance has tightened, as Metro police officers have given a rash of tickets on campus for lack of the sticker. The sticker costs fifteen dollars and is simply an automobile registration tax for Nashville residents and those staying in the county for a period exceeding thirty days. By interpretation of this law, Trevecca students are included in the latter category.

One of the major reasons for students not buying the sticker has been ignorance of the law. Except for a brief reference to the necessity of the sticker at

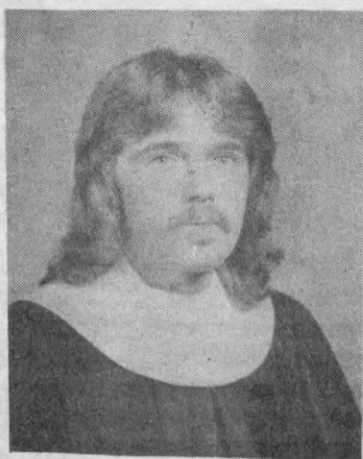
Freshman Orientation, there has been no communication by either the Metro government or the school to the students concerning the law. This resulted in confusion to the point of students questioning the police officers about even the existence of such a sticker while the traffic ticket was being written. Those who have last year's sticker have not been notified of the renewal dates of the sticker, as only permanent residents of the state receive this information directly. These students, however, have not been ticketed.

Another such problem is the disagreement with the law itself. Many students have voiced the opinion that since they are not residents of the state and pay for license registration in their own state, the necessity of college students buying the sticker is unfair. They also point out that out-of-county residents, who may operate a business and use the streets as much or more often than students, are not required to pay the fee simply because they reside elsewhere. Another question arises as to whether or not students are considered residents. This is where the thirty day clause comes in. So the issue for most is not in the legality of the forced registration, but in the justice of it.

The only immediate solution seems to lie in buying the sticker. In all cases, the charges have been dismissed in traffic court upon the presentation of the receipt of purchase. The policemen have emphasized that the only re-

Constitutional Revision Proposed by Council

The 1976-77 Student Council has proposed the following revisions to the Constitution of the Associated Student Body. These proposed changes have passed through the Student Council, and will go before the Administrative Council for approval on Wednesday, March 9. The revisions will then come before the student body for approval Friday, March 11.

1. As stated in the present Constitution, a two-thirds quorum of the membership of the student body is needed for election and ratification of constitutional amendments. Student Council has proposed changing this to a simple majority quorum. This would make the election and ratification processes much simpler, as it is often very difficult to get two-thirds of the student body to vote.
2. Selection of the editors of *Trev-Echoes* and *Darda* will take place in the following manner: a selection committee will be set up after the ASB Elections. The committee will be composed of the newly elected Executive Council (Pres. EX. V.P., Sec. Treas.), the Stuco advisor for the previous year, and the publications advisors and editors for the previous year. Anyone desiring to serve as editor of either publication must petition along with those candidates for ASB offices, and submit a resume to the selection committee. This committee will review the resumes and interview all applicants, and then select the two editors. This revision will encourage greater competency on the part of the editorial positions, and will also create a more professional attitude in the selection of these editors. The purpose of this change is not to remove the vote from

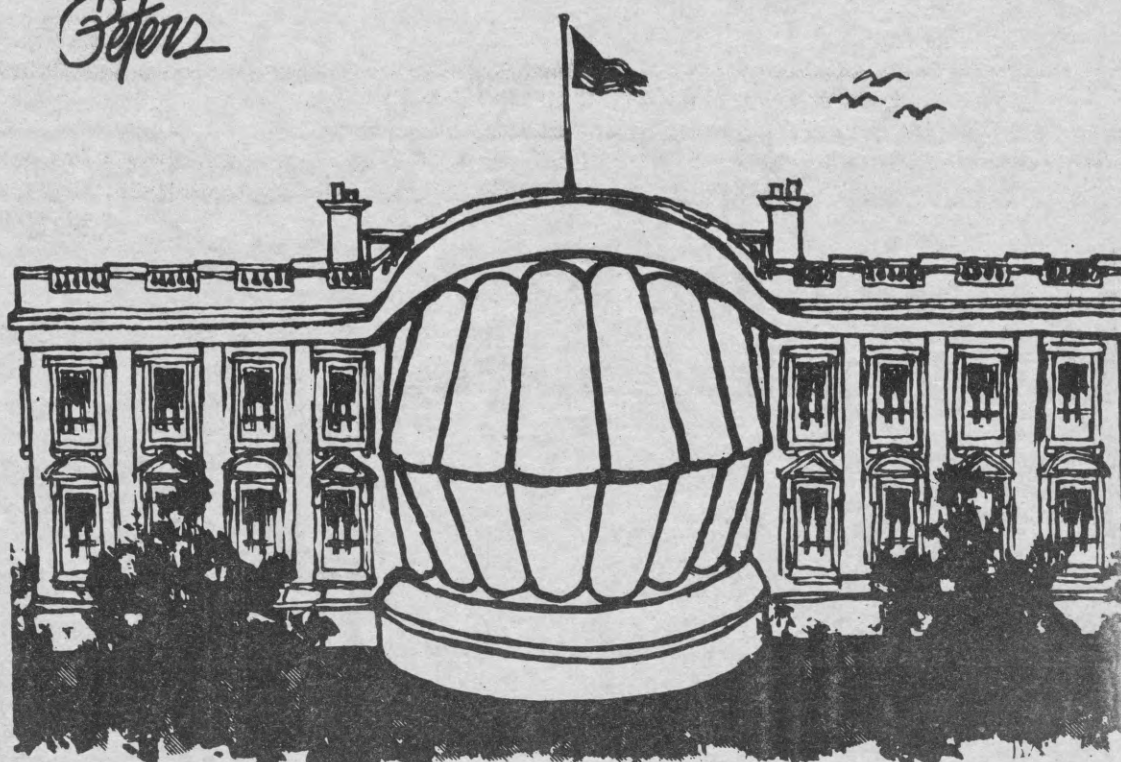

So talk to your class representatives or the chairperson of the CLC subcommittee on Dormitory Life (Stuart Rowan). If you want, you are welcome to come to the meeting. To avoid confusion, though, if you want the privilege of the floor, please clear it with Jeff Klepfer in advance. What I'm trying to say is that it is very easy to complain to everyone except the people that can do something about the situation. Let your representatives know how you feel.

In another article all of the proposed changes to the Associated Student Body Constitution are printed. You will be voting on these changes, so please be aware of them. The STUCO Executive Committee, the Student Activities Committee, and the Student Council as a whole have put long hours into this project. All of the changes have but one purpose—to enable the Student Council to serve you more efficiently and effectively. Please cast your vote wisely when the time comes for you to have your say in the matter.

Finally, did you realize that ASB elections for 1977-78 begin about one week after we get back from spring break? Many of you need to consider what you can do to best serve your fellow students. It might be that you should consider running for a particular office. The work is rewarding, but I warn you—it is time-consuming and difficult.

Just a few points to ponder. Have a good day.

the students, but rather to bring it to a level where the selection may be more easily handled and a greater emphasis placed on competency.

3. A Vice-President of Social Life will be added to the Student Council. This will facilitate the coordinating of all student activities, and will free the Executive Vice-President and the Secretary to more competently handle their jobs. This person will serve as the social chairperson of the campus, and will preside over the Student Activities Committee.
4. The following positions will be eliminated from Student Council: *Darda* and *Trev-Echoes* editors (they will serve as voting members on the Student Life Committee of STUCO). Communicator (duties will be absorbed by the Executive VP), Chapel Chairperson (will serve on the Religious Life Comm.).
5. Candidates for ASB offices will be asked to submit resumes along with their petitions. These will be reviewed by the Elections Committee, who will then make recommendations to Student Council regarding approval of candidates. These resumes will not be used for the purposes of screening, but to encourage competency in ASB positions.

These proposed revisions have not been made lightly or without considerable thought. Various committees of the Student Council have seriously considered all known options before presenting the suggested changes to the entire Student Council. Again, much time and thought was spent in reviewing the changes, and we feel that what we have proposed is what is best for the student body and the institution as a whole. It is the hope of your Student Council that, when it comes time to vote on these revisions on Friday, March 11, you will also have considered these proposals and will be prepared to vote knowledgeably.

Support Revisions to ASB Constitution

Probably the most controversial proposed revision to the ASB constitution is the process for selecting the Editors of the *DARDA* and *Trev-Echoes*.

Much of the controversy stems from the fact not that this wouldn't be a better method of selection of editors, but that it is a drastic change from the present system.

When this amendment was introduced in *STUCO*, there was plenty of discussion. Student Council carefully and in great length weighed the pros and cons of each method. When the vote was taken 14 were in favor of the new amendment, 3 against and one abstained from voting.

Now that you know how the council voted, here are some of the reasons why the vote was so strongly in favor of this amendment.

To start off, this new process of selection would mean editors would be chosen on the basis of journalistic knowledge, experience and qualifications, which is a must for an editor to be effective needless to say.

It should be pointed out that both of the present editors, Karen Carter and myself, voted to support this amendment. One reason the change was supported in *STUCO* is due to the fact that most editors from other schols are not elected by popular vote of the student body. Draw from your own experience on this point in considering process of selection for editors in the schools other than Trevecca that you've attended.

Lastly, the student body can trust the decision of the members in the Council concerning this. Obviously the amendment would not have been introduced if the ones who are acquainted most closely with the situation were not doing their jobs and were closing their eyes and minds to the realization that the change is necessary.

ason for the tickets at this point is to encourage students to buy them before the deadline. As for future situations, there has been expressed the wish for the school to cooperate with the city government in providing the sticker at registration in September. This may be impossible due to the sticker's term running from April through March, but arrangements might possibly be made for some sort of availability on campus or simple notification without the negative motivation of a ticket. Of course, some continue to feel strongly against the necessity of the sticker itself, due to

poor conditions of the roads, the use of campus streets by trucking companies, and the ever popular tight budget of the average college student. The answer here may be in the administration's working with the city officials or in simply writing a city councilman. However, until the law is changed, students will be held responsible. The sticker is available at Howard School Office Building on Second Avenue, north of Trevecca, off Murfreesboro Road. The deadline is March 31—after that, the traffic-court judge might not be so understanding.

Trojan Baseball: Hopes High for 1977

Preparation for the 1977 Trojan Baseball Season is in full swing. Anticipation for 1977 is high, with ten lettermen returning from a remarkable 32 and 21 season last year, and the addition of five transfers and three freshmen. This year's schedule looks to be the most ambitious in Trojan Baseball history. Such opponents as Vanderbilt, Western Kentucky University, Nebraska Wesleyan, and Tennessee Wesleyan appear for the first time.

Returning lettermen include All-VSAC and All-NAIA District 24 catcher Kenny Thomas. Kenny, last year's MVP, led in many offensive categories, including RBI's, 57; runs scored, 47; doubles, 11; homeruns, 12; walks, 46, and total bases, 104. Tommy Hawkins returns with his "Golden Glove" and a 1976 fielding average of .945 and only 7 strikeouts in 142 at-bats. Southpaw Troy Whitley was winner of seven games last year and recorded 71 strikeouts in 88 innings and a 3.87 ERA. Speedy infielder Terry Johnson appeared in only 8 games last year, but still boasted a .375 batting average. Outfielder Frank Pinson and pitcher Tab Taylor return but will be taking turns at covering first base. Pitcher Mike Mitchell was 6 and 2 last year and did a good

job as the (DH) designated hitter, with 3 triples, 6 homers, and 47 RBI's. Rob Gassie will again see action as an outfielder or pitcher and is a good line drive hitter. Mike Oliver and Rick Brenner complete the list of returnees and should greatly aid the pitching staff.

Transfers include Jim Bennett who was the All-Star second baseman for TJCAA in 1976. His .368 career batting average (plus only 13 strikeouts in 220 at bats in 1976) and his talent for stealing bases should earn him the spot of lead-off batter. Barry Bennett, who last year was one of the top base-stealers nationally, with 32 stolen bases in 33 attempts, comes from Cumberland College to take over shortstop. The outfield should be much improved with the addition of transfers Greg Robinson, from Vol. State; Gary Clark, from Stratford High School; and Rob Irwin, coming from Slippery Rock College with a shotgun arm but rifle-like accuracy.

Freshmen are old-timer Senior Babe Ruth League MVP for 1976 Randy Burgett, Kevin Sanderson from St. Pete, Fla., and Gary Spahr from Bethal Park, Penn. Burgett and Sanderson will be starting moundsmen, while Spahr will be utilized as a DH, catcher, and possibly as a pitcher.

Coach Bill Green believes that the talent of the 1977 squad is the

best ever at Trevecca. It is now the responsibility of the players and coaching staff to develop the proper mental attitude and "togetherness" necessary to mold raw talent into a "Team." The Trojans Premier is Saturday, March 12, as they play host to Nebraska Wesleyan. Support the Baseball Program in 1977.

TIA Basketball Closes Season

The 1977 Intramural Basketball season has ended and all societies, except Beta, share in at least one league championship. Gamma captured the men's "A" league with a perfect 6-0 record. Alpha took the title from Delta in the playoff game to cop the "B" league, and Delta again won the "C" league and women's league with 5-1 and 6-0 records, respectively.

The leading scorers for the Men's "A" league this year were Steve Childress (Beta-23.9), Darrell Hall (Delta-18.9), Tommy Smith (Gamma-18.0), MVP Tim Templeton (Alpha-17.9), and Terry Maxwell (Gamma-17.5). Tony Lindsay won the sportsmanship award. In the game that matched the champion Gamma men against the League All-Stars, Gamma won 77-69 behind the scoring of Mike Mitchell (24), Smith (19), and Maxwell (18). Pacing the All-Stars and alternates were Hall (15), Childress (14), and Templeton (13).

MVP Phil Steward was the High-Point man for Delta and led all other scorers throughout the year in the "B" League with a 20.2 PPG Average. Following him were Alpha's Wes Hinton

(14.9), Gamma's Andy Warren (13.3), Alpha's Tim Taylor (12.1), and Beta's Bob Clark (11.1). When Alpha and Delta met to playoff their 4-2 record tie, Alpha ran away with a 75-46 victory. Taylor scored 23 points and Hinton and Ronnie Bailey sportsmanship followed with 15 and 11 points, respectively, to aid Alpha. Stewart put in 16 points and David McGrath scored 13 to keep Delta somewhat in the game.

The "C" league saw three teams bidding for the top spot until the final two games of the season spread the standings. Delta came out on top with a 5-1 record. Highlighting the scoring were, from Gamma, MVP Sam Mitchell (15.9); from Delta, sportsmanship award winner Jim Coulston (13.9) and Dean Murray (12.1); and from Beta, Wes Shaeffer (11.4) and Jeff Long (9.0). The "C" league All-Stars and alternates met the Delta men

and beat them 42-39. Beta's Rob Gassie pumped in 14 points and Mitchell followed with 10 to keep the All-Stars out in front the whole game. Coulston and Murray tried hard to gain the win by scoring 14 and 11 points.

In Women's Intramural Basketball action, Delta dominated the court all year. The top three scorers in the League were from Delta. They were Joy Seales (14.1), MVP Jane Lovell (9.6), and Margaret Fitzwater (9.0). Behind them were sportsmanship award winner Diane Marshall (6.0) from Beta, and Gamma's Karen Jones (5.1). Delta's dominance fell when the lady All-Stars defeated them 24-23 on an outside shot by Beta All-Star Cheryl Heaberlin with 10 seconds remaining in the game. Seales (13), Lovell (8), and Fitzwater (2) did all of the scoring for Delta, and Jones (7) and Heaberlin (6) led the All-Stars.
